



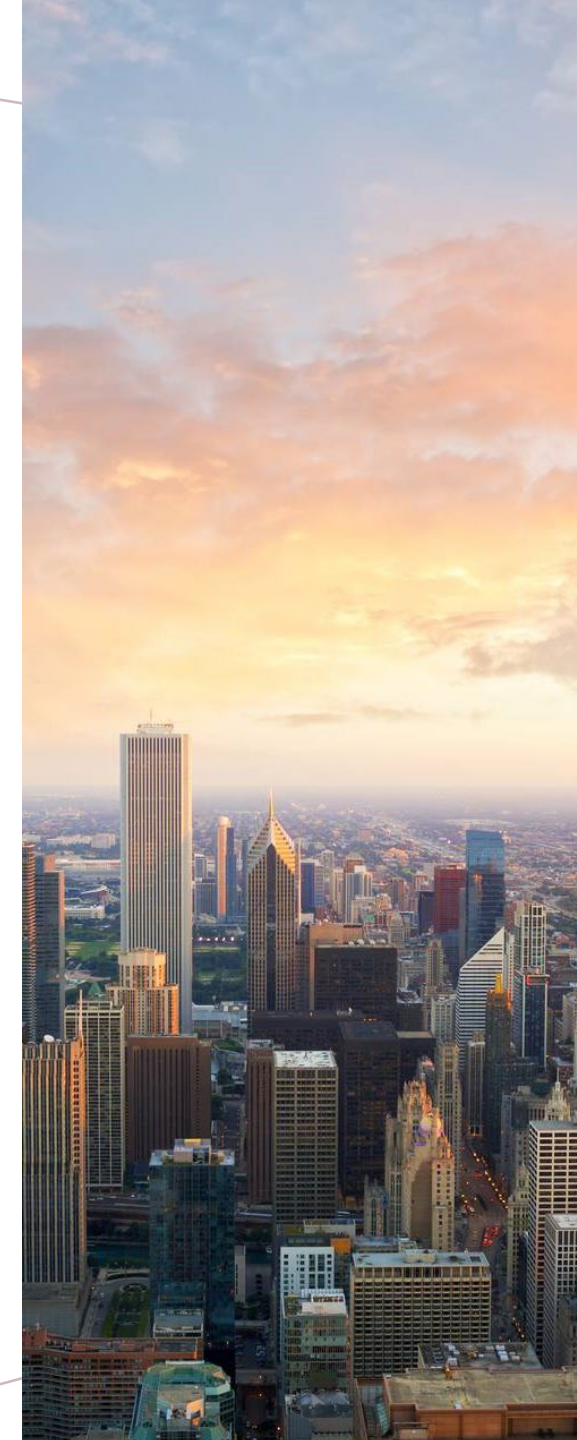

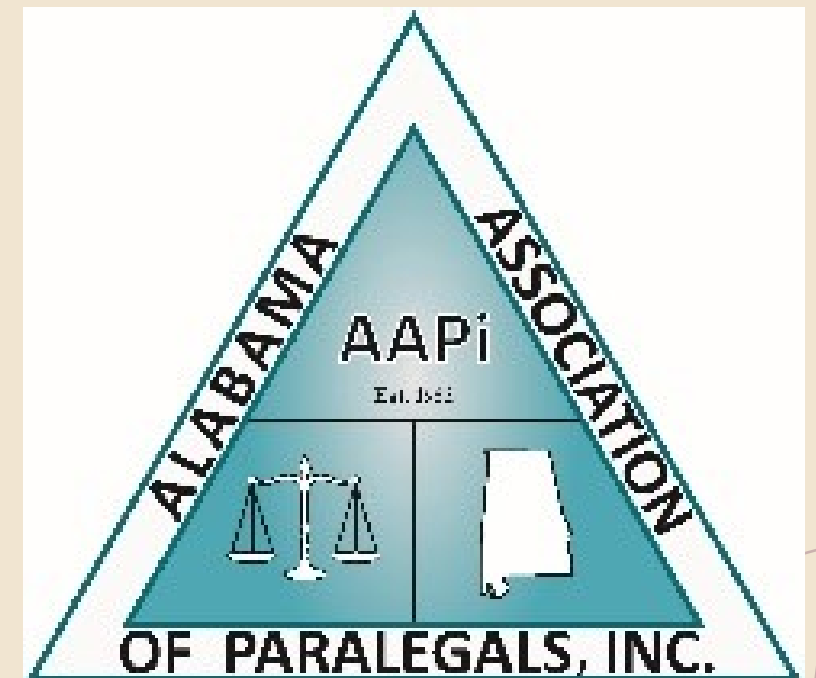

The Alabama Association of Paralegals, Inc. (AAPi) is excited to kick off 2026 with our first seminar of the year—the 2026 Winter Seminar!

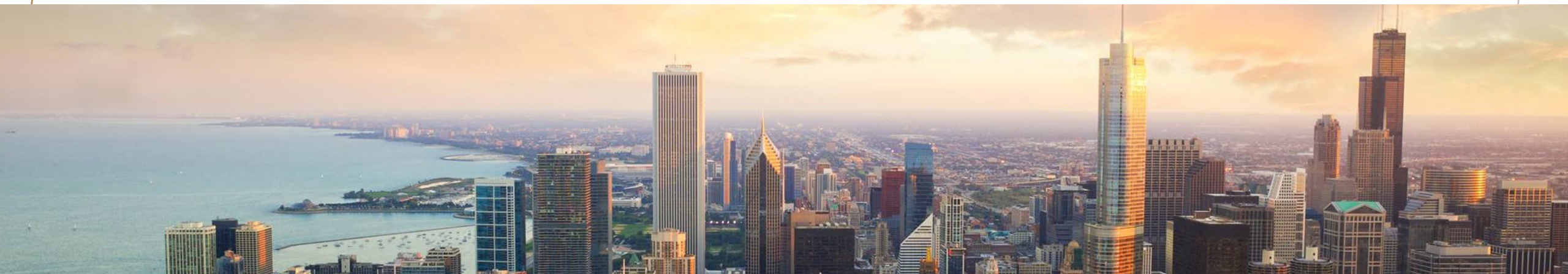

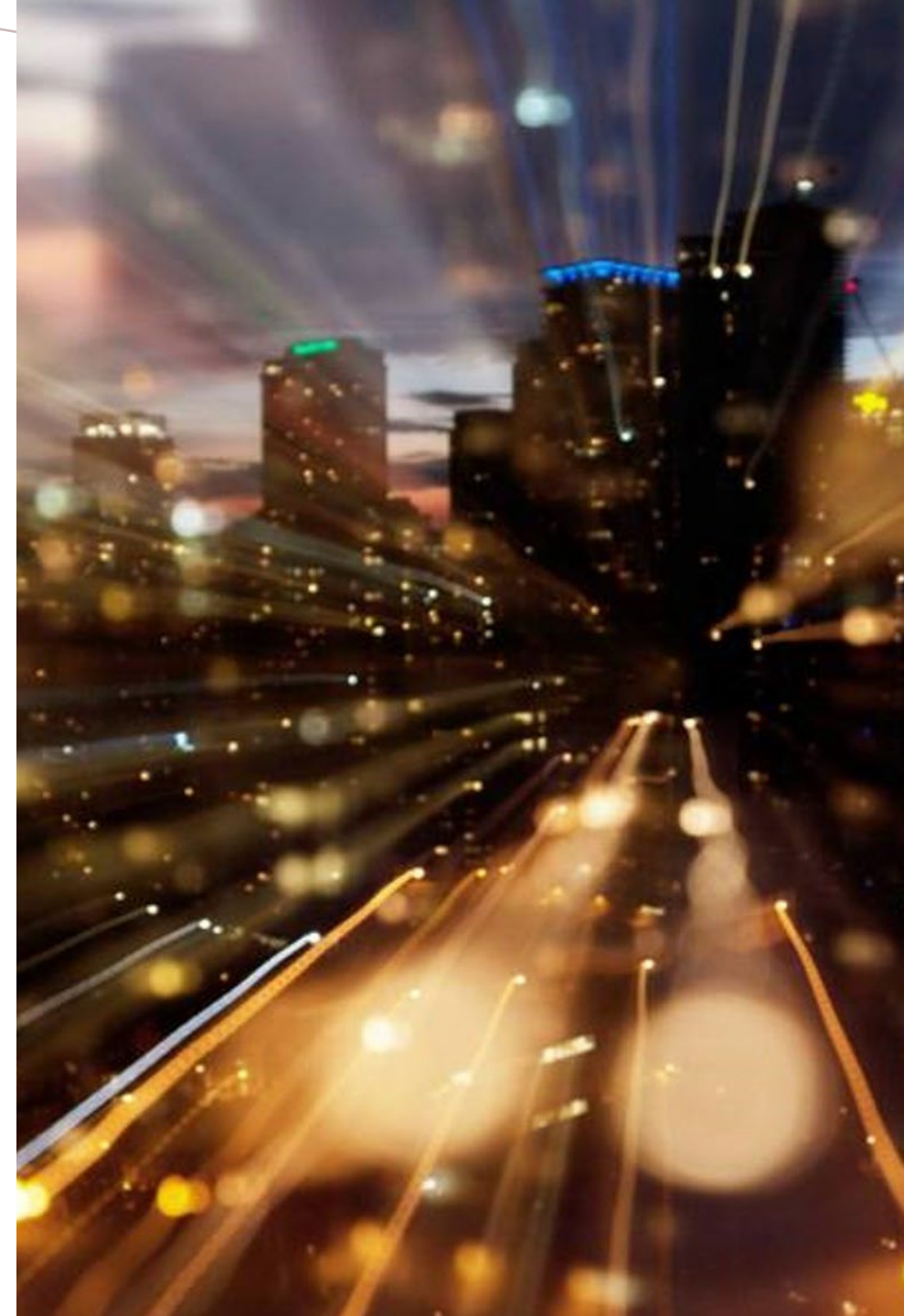
